#### **TEAM COACHING**

**Client:** Business finance company serving companies with recurring revenue.

Challenge: Client needed a \$250M capital increase to extend funding to new clients. However, path to target

profitability and team strategy to secure success was unclear

**Deliverable:** Executive Team Coaching

**Innovation:** Executive Leadership System<sup>™</sup> software used to support vision of executive team and provide

guidance for attracting, engaging, and growing relationships with clients.

Result: \$250M secured, several new business clients funded

#### **EXECUTIVE COACHING**

Client: Investor & International Call Center CEO

Challenge: Investor/CEO was plagued by unrelenting tasks due to lack of boundaries and overwhelmed by demands of non-performing team members and collaborators. This impacted his business goals for profitability and dream to care for children abroad.

**Deliverable:** Executive Coaching

**Innovation:** Coaching assisted client in strengthening leadership voice, creating boundaries, delegating tasks and focusing more on his dream to support children.

**Result:** Client gained clarity, restructured investments and call center teams. The business went from loosing employees and being negative in revenue to a 250 employee, multi-million dollar profit center within 2 years. He recently sold the firm and now uses proceeds to fund orphanages in Southeast Asia.
